Pursuant to the blanket Statement of Authorization granted to United Air Lines, Inc. ("United") and Lufthansa German Airlines ("Lufthansa") on April 9, 1998 (Order 98-4-8), United and Lufthansa hereby notify the Department that United's "UA" designator code will be placed on flights operated by Lufthansa:

→ between Munich (MUC) and Sofia, Bulgaria (SOF)

The proposed code-share service is extra-bilateral, but United already has the necessary DOT authority to serve Bulgaria via Germany and has received approval from the Bulgarian government to start the service. The services will be implemented on or about December 22, 2001.
