**NOTICE OF TRADE NAME REGISTRATION**

On July 15, 1997, Air Nevada Airlines, Inc., a certificated air carrier, filed, pursuant to 14 CFR Part 215, a notice of its intent to register the trade name "Pacific Wings" for use in certain of its operations. At the same time, the carrier stated that it desired to relinquish use of the trade name "Alii Air," which it had registered on January 22, 1996.

Part 215 of the Department's regulations requires that, before an applicant may register a proposed name or trade name with the Department, it first must notify any other air carriers with the same or a similar name of the proposed usage and then certify to the Department that this notification has been accomplished. After searching our records, we have determined that there are no other carriers with the same or a similar name which the applicant would need to notify of its intended trade name registration.

Since the requirements of Part 215 have been met, we orally advised the carrier on July 29, 1997, that we had accepted its registration of the trade name "Pacific Wings," effective on that date, and we confirm that action by this notice.<sup>1</sup>
