**NOTICE OF POLAR AIR CARGO, INC.**

Pursuant to Orders 02-2-2 and 01-11-15, Polar Air Cargo, Inc. (“Polar”) submits the following notice identifying each limited-entry market subject to the blanket dormancy waiver contained in Order 01-11-15 in which Polar will not resume service as of April 1, 2002:

- Allocation of three (3) weekly U.S.-South Africa all-cargo frequencies (Docket OST-97-2939). Polar does not intend to seek a further dormancy waiver with respect to these three frequencies.
- Allocation of two (2) weekly U.S.-Saudi Arabia all-cargo frequencies (Docket OST-98-3652). Polar intends to seek a limited dormancy waiver to maintain

these frequencies in effect and will file such an application shortly.
