CLARIFICATION TO MOTION OF JETBLUE AIRWAYS
CORPORATION FOR CONFIDENTIAL TREATMENT

On May 3, 2002 JetBlue Airways Corporation (“JetBlue”) filed pursuant to Rule 12 a request for confidential treatment of certain information contained in JetBlue’s Form 41 filing for the quarter ending December 31, 2001. That request asks for confidential treatment for Schedule B-7 – Airframe and Aircraft Engine Acquisitions and Retirements. It did not also ask for, although the schedule was filed confidentially, for confidential treatment of Schedule B-43. Pursuant to this filing JetBlue asks for confidential treatment of both schedules consistent with, and pursuant to, its original Motion. As to Schedule B-43, JetBlue requests confidential treatment of columns 10, 11, 12 and 13. Amended Index A is included for ease of reference.

Wherefore, JetBlue Airways Corporation respectfully requests that the confidential information contained in Schedule Forms 41 B-7 and B-43, as detailed above, be withheld from disclosure for at least ten (10) years.
