Pursuant to section 302.12 of the Department's Rules of Practice, Kalitta Charters II, LLC, hereby moves to withhold from public disclosure Exhibit D to the above-captioned application for the transfer of a certificate of public convenience and necessity. These documents are being filed with this Motion in a sealed envelope marked "Confidential Material - Rule 12 Treatment Requested." In support of this Motion Kalitta Charters II, LLC., submits the following:


The items included in Exhibit D are the financial statements for Kalitta Charters, LLC.

The information Kalitta Charters II, LLC. seeks to withhold from public disclosure is (1) commercial or financial, (2) obtained from a person outside the government, and (3) privileged or confidential. Moreover, release of this information would cause substantial harm to the competitive position of Kalitta Charters II, LLC, or the individual from whom the information was obtained.

Exhibit D contains sensitive financial information about Kalitta Charters, LLC. The information in this Exhibit is highly detailed and would not otherwise be made accessible to persons outside the company. Because this information is not currently required to be filed by a Part 135 operator, the disclosure of this information would give the competitors of Kalitta Charters, LLC., and unfair advantage in the charter market.

Therefore, this information should be afforded confidential treatment by the Department.
