American Airlines, Inc. hereby moves for immediate action by the Department to issue revised interim and final international mail rates for the period January 1-December 31, 2003.

By show-cause Order 2002-12-23 in this docket on December 31, 2002, the Department proposed tentative rates for the current calendar year, based in part on Form 41 data provided by Delta Air Lines, Inc. American and United Air Lines, Inc. both objected to the proposed rates, urging that the underlying data submitted by Delta was inaccurate.

On March 19, 2003, Delta filed relevant revised data. The Department should now take immediate action to establish new interim and final rates based on Delta's corrected data in order to provide fair and reasonable compensation to carriers during the present period of intense economic distress.
