Delta Air Lines, Inc. ("Delta") hereby supplements its September 21, 1999, certificate application by adding Portugal to the list of countries included in Exhibits A and A-2, attached to Delta's initial application and first supplement, respectively.¹ For the sake of administrative convenience, attached hereto is a revised Exhibit A, listing all of these points.

On December 22, 1999, the United States and Portugal reached an open skies agreement. Since Portugal is now an open entry country, Delta should be granted indefinite certificate authority to provide scheduled service to any point in Portugal for the reasons stated in Delta's initial application filed in this Docket.
