Mesa Airlines, Inc. ("Mesa") hereby notifies the Department that it intends to suspend all air service at the following point in 90 days from the date of filing of this notice:

Cody, Wyoming

1. Mesa's address is: 2325 E. 30th Street, Farmington, NM 87401 and its telephone number is: (505) 326-4410.
2. Mesa holds a certificate of public convenience and necessity, issued by the Department's Order 90-10-19.
3. There are is one other air carriers operating to this point, Delta Air Lines, which operates to Salt Lake City, UT.
4. The service to be suspended is set forth in the schedules attached hereto as Exhibit A. It is provided with Bombardier Dash-8 (200 series), 37-seat, twin turboprop aircraft.
5. The 90-day period prior to suspension will end with December 30, 1997.

6. The Department has made a determination of the level of essential air service for the point involved (Order 83-10-39) and Mesa's suspension will reduce service below the determined EAS level.
7. Objections, if any, to this Notice are due on October 21, 1997.
