APPLICATION OF NORTHWEST AIRLINES, INC.
FOR RENEWAL OF EXEMPTION

Northwest Airlines, Inc. ("Northwest"), pursuant to 49 U.S.C. § 40109 and Part 377 of the Department of Transportation ("the Department") Special Regulations, 14 C.F.R. § 377.1 et seq., hereby applies for renewal of its exemption from 49 U.S.C. § 41101 authorizing Northwest to provide scheduled service between points in the United States and the following foreign points, via Amsterdam: Dubai, United Arab Emirates (U.A.E.); Accra, Ghana; Bahrain, Bahrain; and Sanaa, Yemen. The Department last granted Northwest exemption authority to serve these points by Notice of Action Taken dated February 6, 1996, effective beginning January 18, 1996 through January 18, 1998, and confirmed by Order 96-3-17 (Docket OST-95-741). Northwest intends to serve these markets pursuant to its code-share agreement with KLM Royal Dutch
