90-DAY NOTICE OF MESA AIR GROUP FOR SUSPENSION OF AIR SERVICE

As the result of the loss of code sharing with United Air Lines, Mesa Air Group, Inc. ("Mesa") is notifying the Department that it intends to suspend all air service at the following point in 90 days from the date of filing of this notice:

Great Bend, Kansas

1. Mesa's address is: 2325 E. 30th Street, Farmington, NM 87401 and its telephone number is: (505) 326-4410.
2. Mesa holds a certificate of public convenience and necessity, issued by the Department's Order 90-10-19.
3. There is no other air carrier operating to this point.
4. The service to be suspended is set forth in the schedules attached hereto as Exhibit A. It is provided with Beechcraft 1900, 19-seat, twin turboprop aircraft.
5. The 90-day period prior to suspension will end with May 18, 1998.
6. The Department has made a determination of the level of essential

air service for the point involved (Order 94-10-16) and Mesa's suspension will reduce service below the determined EAS level.

7. Objections, if any, to this Notice are due on March 9, 1998.
