On June 18, 2003, Atlasjet Uluslararası Havacılık A.S. ("Atlasjet") filed an application for a foreign air carrier permit under 49 U.S.C. § 41301 and an application for an exemption under 49 U.S.C. § 40109(c).

Following the filing of an answer and a reply, on July 18, 2003, Atlas Air filed an unauthorized "Rejoinder" together with a motion for leave to file an unauthorized document in both the permit and exemption proceedings.
