1. Pursuant to the direction contained in Order 2005-2-8, Continental supplements its application to explicitly request a designation for the Los Angeles-Mexico City route.


2. The additional information required by Order 2005-2-8 is contained in Continental's exhibits, submitted contemporaneously with this supplement.


