ORDER CANCELLING FOREIGN CERTIFICATE

By Order 2005-3-29, issued March 22, 2005, we cancelled the Section 41102 interstate scheduled passenger certificate of public convenience and necessity issued to Allegheny Airlines, Inc. d/b/a US Airways Express (Allegheny) by Order 98-7-6.

By this order, we are canceling the company's companion foreign scheduled passenger certificate authority. Instead of repeating our findings and conclusions in Order 2005-3-29, we incorporate them here by reference.

ACCORDINGLY,

1. We cancel the certificate of public convenience and necessity issued to Alleghany Airlines, Inc., by Order 98-7-6, authorizing it to engage in foreign scheduled air transportation of persons, property, and mail.
2. Unless disapproved by the President of the United States under section 41307 of Title 49 of the United States Code, this order shall become effective on the 61st day after its submission for section 41307 review or upon the date of receipt of advice from the President or his designee under Executive Order 12597 and implementing regulations that he or she does not intend to disapprove the Department's order under that section, whichever occurs earlier.¹
3. We will serve a copy of this order on the persons listed in Attachment A.
