Dear Ms. Rosenberg and Mr. Wellington:

Pursuant to the blanket Statements of Authorization granted to United Air Lines, Inc. ("United") and Deutsche Lufthansa AG ("Lufthansa") by Order 98-4-8 issued April 9, 1998 (Undocketed), Lufthansa CityLine GmbH ("Lufthansa CityLine") by Notice of Action Taken dated July 15, 2003 (Docket OST-03-15485) and Air Dolomiti SpA Lare ("Air Dolomiti") by Notice of Action Taken dated April 17, 2002 (Docket OST-02-11856), United and Lufthansa (on behalf of itself and its subsidiaries, Lufthansa CityLine and Air Dolomiti) hereby notify the Department that, effective on or after December 14, 2005, United's "UA" designator code will be displayed on flights operated by Air Dolomiti¹ between:

- Frankfurt, Germany and Florence, Italy
- Munich, Germany and Florence, Italy
- Munich, Germany and Milan, Italy
- Munich, Germany and Nice, France
- Munich, Germany and Rome, Italy

¹ United, Lufthansa and Lufthansa CityLine have previously given notice to the Department of code-share services between certain of these points, but are jointly giving this notice as these routes may now also be operated by Air Dolomiti and/or Lufthansa CityLine on Lufthansa's behalf.


The proposed code-share services are consistent with the bilateral air transport agreements between the United States and Germany, Italy and France.


