Air One S.p.A. ("Air One"), an Italian combination air carrier, hereby amends its October 20<sup>th</sup> 2005 Application for (i) an exemption from 49 U.S.C. §41301 and (ii) a Statement of Authorization under 14 C.F.R. Part 212 to the extent necessary to engage in codeshare operations with US Airways for certain Italian city-pair segments of US Airways' U.S.-Italy and Italy-U.S. flights.

Air One amends its application to remove the Rome-Milan (Linate) city pair from the list of Italian city-pairs covered by the Application. A revised Exhibit A, showing all city pairs now covered by the Air One's Application, is attached hereto.

Air One respectfully requests that the Department of Transportation approve the Application, as amended, as expeditiously as possible, and grant such other relief as it deems appropriate.


