**NOTICE OF ACTION TAKEN -- DOCKET OST-97-3126**

This serves as notice to the public of the action described below, taken by the Department official indicated (no additional confirming order will be issued in this matter).

Application of American International Airways, Inc. filed 4/8/98 in Docket OST-97-3126 for:

**XX** Exemption from Order 97-1-17; startup deadline:

By Order 97-8-20 the Department granted American International Airways exemption authority to provide scheduled all-cargo service in the U.S.-Ecuador market and allocated it three weekly all-cargo frequencies for this service. That award was subject to the condition that it will expire automatically and the frequencies will revert to the Department for reallocation if they are not used for a period of 90 days. Under the terms of the order AIA's frequency allocation would expire November 20, 1997, if AIA did not begin service by that date. By Notices of Action Taken dated November 19, 1997, and January 16, 1998, the Department granted extensions of the startup date through April 20, 1998. (See Orders 97-12-15 and 98-3-1.) AIA seeks extension of the April 20 startup date to June 19, 1998. AIA believes that the necessary approvals by the Ecuadorian authorities will be secured by June 19, 1998.

This action was effective when taken, and the filing of a petition for review will not alter such effectiveness.
