MOTION OF DELTA AIR LINES, INC.
FOR AN EXTENSION OF DORMANCY WAIVER

Delta Air Lines, Inc. ("Delta") hereby moves for an extension of the temporary dormancy waiver applicable to the New York/Newark-Cozumel route. On January 11, 2006, the Department granted Delta a dormancy waiver for certain U.S.-Mexico routes due to the impact of Hurricane Wilma, including, *inter alia*, New York/Newark-Cozumel. Delta anticipates that it will restore most of its Cancun services in June, 2006.

However, Cozumel is a smaller market and many of its hotels are still under construction. In light of the market conditions and ongoing recovery efforts, Delta has decided to defer implementation of its planned JFK-Cozumel service until December 16, 2006. Accordingly, Delta requests an extension of its dormancy waiver to run from that date.


