To provide clarity with respect to the intentions of the Applicant, when Polar Worldwide commences air carrier operations following completion of the corporate reorganization, it will do so with flight crewmembers formerly employed by Polar, who are to become employees of Polar Worldwide. When this occurs, Polar Worldwide will assume and be bound by the Polar-ALPA collective bargaining agreement.


